In construction, as in many other sectors, the saying of "a little goes a long way" is unfortunately not generally true - capital projects tend to reflect the level of investment in them. However, when a relatively modest investment is coupled with great design, the results can be spectacularly successful.

In 2001, the congregation of St Andrews United Reformed Church in Monkseaton, set up a Development Committee to investigate the feasibility of improving the accessibility and toilet provision for their heavily used Church Hall adjacent to the Church. Built in 1939, the Church itself was also in need of some investment for new lighting and the then Minister, Gordon Connacher, turned to ourselves for initial designs after being impressed by our work at St Oswald's Hospice in Gosforth.

JDDK Director and Project Architect, Ian Clarke, explained the challenge, "The Church and Church Hall were connected by a utilitarian link block which had created a little used courtyard to the front of the buildings, yet the Hall itself was very heavily used together with its limited toilet and kitchen facilities. The design required a way to tie the two buildings together, creating additional interior space, improving accessiblity and facilities, and providing a central point of welcome. The new work had to be visibly sympathetic to the existing architecture and respond to the human scale and character of the surrounding suburban houses in this packed residential Conservation Area. We had an unknown but limited budget, which would depend on fund raising for the whole project."

Some seven years later, the results of the congregation's fund raising work, which has raised £600,000 in the intervening period, the architects' designs and the construction work by DP Builders of Amble were officially opened in a celebration weekend by Rowena Francis, Moderator of the Northern Synod of the United Reformed Church.

The development has created an entirely new entrance to the Church Hall which compliments and reinforces the existing architecture whilst answering the brief of refurbishing and improving the building., as Derek Stembridge, Treasurer of the Development Committee, commented, "The project had begun by looking at improving access to the Hall, but it became apparent that with over 1,000 people using the facility a week, including over 400 children, there was a real need to improve the building and we began to think of something on a grander scale!"

"Our main concern over the construction has been to be to minimise any disruption to the local community as the streets are very narrow around the Church and the builders have been very good here, particularly the Site Manager, David Curtis, with the result that there hasn't been a single complaint. The overall objective was to support the local community and we now have a superb facility in which all are welcome as we build for the future."

The new entrance is absolutely stunning but only hints at the interior where the Church Hall has been totally transformed to create a superb facility for the local community. The entrance leads into a light filled reception area with servery and then into the Hall with a new toilet block complete with disabled access facilities. In addition, new lighting, flooring and decoration has transformed



A Visit to the Dentists

Our project creating the new Kingswalk Dental Implant Practice opened in January after the fast track, listed building, project was successfully completed on time and within budget.

The £370,000 development undertaken by Northallertoncontractors Walter Thompson Ltd. saw the conversion of a Grade II listed Georgian terraced property on Leazes Park Road in the centre of Newcastle from an office to a highly serviced dental surgery for the Kingswalk Practice who were relocating from their premises on the edge of the University campus. With a client base consisting of numerous University staff and students, the practice were obviously keen to remain in the immediate area.

The project, however, was not without challenges for JDDK primarily due to the delicacy and ingenuity that was required to design the necessary alterations in a manner that met the exacting requirements of the planning and conservation

officers in the local authority. At the outset of the project there was concern from the planners as they feared that the construction work required, such as strengthening of the floor boards in each surgery to take the weight of the equipment and the distribution of services would alter the very fabric of the listed building. We worked hard to develop technical solutions that protected the historic building and its important original features while still meeting our client's requirements and as a result our planning and listed building submissions contained virtually working drawings to show how the conversion could be carried out in an acceptable

The end result is a four storey Georgian terraced property which contains three fully equipped hi-tech surgeries which surpass the latest statutory requirements for dental surgeries, a central sterilising room, staff area and ground floor reception, waiting area and offices.

Hospice Update The Glasgow Marie Curie Hospice

Whilst many construction sectors have certainly been adversely affected by the economic climate, our workload with hospices has continued and even grown over the last years with good progress on Design work continues on the West several projects.

In January, the new £16m Marie Curie Hospice in Glasgow opened its doors to patients for the first time, replacing the existing hospice which was built in the 1970's. Built on a steeply sloping site within the campus of Stobhill Hospital on the north east edge of Glasgow, the hospice provides space for thirty inpatients, a day hospice and outpatients suite, training and education spaces for health professionals, a regional base for staff working in the community, and all the supporting accommodation.

At our first visit several years ago, the site appeared daunting, but with the great advantage of wonderful views of the Campsie Fells from the upper parts of its slope - hence the reason the bedrooms are located here to give the bedrooms and patient terraces a wonderful view.

The building is split over three different floor levels, with the advantage that each level has garden access because of the slope. At the lowest level, the Day Hospice is close to the main entrance and with a sheltered south facing

make the best of a Scottish summer. We hope to have a full feature on the hospice in the Autumn issue of Millmount News.

Midlands Marie Curie Hospice, after planning permission was received in late 2009. Whilst without the challenge of a steeply sloping site, the greenbelt location of this project on the south western edge of the Birmingham conurbation has meant that visual and ecological sensitivity have played particularly important parts in this project. Collaboration with the Warwickshire Wildlife Trust has been extensive, and our wildlife garden over which the patient bedrooms will look will include webcams so that patients can have a close-up of the action in the garden!

In Edinburgh, the "Buy a Brick" fundraising appeal for the St Columba's Hospice project, (www.bluedove.org.uk), which received planning permission last year with support from Historic Scotland - the site includes important Listed Buildings and is located in the Trinity Conservation Area.

In Cork, Ireland, our contractors, BAM. are proceeding at pace with the new Curraheen hospital which is scheduled for completion around the end of the

The latest in our series of SureStart/Community Centres, the £735,000 Brunswick Park Centre was successfully handed over by contractors NCS Build to our client. Newcastle City Council. in early January.

Similar in design to the earlier Grange Centre in Gosforth, the single storey building provides a shining example of how good design matched to traditional construction techniques can produce buildings which are both a costeffective and architecturally interesting solution to the client's brief.

Constructed in traditional load-bearing block and brickwork with partial timber cladding, the internal design has created both practical and interesting spaces with two large 'L' shaped meeting rooms separated by a removable screen, a large kitchen which can be used for training purposes, front office and toilets. To the side of the building are two changing rooms and showers with separate access from the football fields within the park. Solar panels on the pitched roof provide partial hot water for the building and showers.
