### INTRODUCTION



We are a Newcastle-based architectural practice with over 35 years of ongoing, developmental and iterative experience in the field of hospice design; throughout this time we have worked on over 50 hospice projects.

Our work in this field began when our founder won a competition to design a local hospice, St Oswald's, marking the start of an exciting architectural journey working with many hospices across the UK and Ireland which continues to this day.

We hope this booklet gives a taste of our evidence-based approach to design of not only Adult Hospices but also Children's Hospices and the often overlooked facilities for Adolescents.

Our projects range geographically from Inverness to London whilst we also continue to work in Ireland. They range in scope from entire new facilities to more modest upgrades of existing facilities and whilst all are different, our approach of Discover, Design and Deliver remains constant in that our initial work involves research and consultation, then goes through design and further consultation, before delivery and management of the construction process. In many cases, we have extended our relationship with our clients by finally undertaking the crucial post-occupation evaluation research which is then fed back into new projects.

We hope you like what you see and look forward to being of service to your own organisation.





## RESEARCH

We work closely with many organisations, including our three local Universities of Durham, Newcastle and Northumbria, on a variety of Hospice Design research programmes whilst we have also worked with Northumbria University on Post-Occupancy Research where we revisited 12 of our projects.

The JDDK Hospice Initiative examined how the 12 hospice clients felt about both the initial design process and how the resultant building responds to their requirements and whether it promoted patient well-being.

Northumbria University then carried out their own independent research into the development of hospice design involving statistical analysis of patients over the last 30+ years and how hospice design has impacted on this.

The results are available for use by other professionals including fellow architects, as a reference bank when coming to design spaces for palliative care.

We have worked closely in collaboration with both Newcastle and Durham Universities on the En'Light'en Project with St Oswald's Hospice in Newcastle.

The impact of the physical environment on well-being is the focus of the project and how healthcare spaces can be changed to positive effect, with the aim of reducing stress, creating uplift and improving health outcomes. Research has clearly demonstrated the benefits of the natural environment on human health and wellbeing, yet we spend most of our time in constructed spaces, often with limited views out and with little exposure to natural light. Using qualitative and quantitative methodologies, we will explore the influence of lighting and other sensory installations, inspired by the natural environment, upon health and wellbeing in multiple settings at all times of the day and night.


Secondly, I would look for wider professional skills such as client care, delivering to budget and programme. Leading the design team and being a significant part of the wider team are examples of this.


Stuart Franklin | Associate Director


Nicky Hodgson Associate Director
